- Qualified subscriptions are not included.
- The subscription of State Participant to ADF-X is partially qualified
- State Participant has not subscribed to ADF-X.
- USA's subscription to ADF is qualified as follows: ADF-VIII: UA 162,337 ; ADF-IX: UA 23,276,286 ; ADF-X: UA 94,509,183

- Norway made a voluntary contribution of UA 11.9 million. Voluntary contributions do not carry voting powers.
- Argentina only subscribed to ADF-III
- UAE only subscribed to ADF-II
- MDRI Resolution provides in paragraph 8 the allocation of voting rights
- During the ADF-X Mid-Term review in The Hague, Netherlands made an additional pledge of UA 17,020,105.48 to reduce the ADF-X subscriptions gap. This contribution was paid on 13 December 2006 and generated a supplementary contribution, through accelerated encashment, of UA 1,194,819.97
- The United Kingdom has made an additional subscription to ADF-X which increases the country's burden share from 6.5% to 7.5% on 28 March 2007
- Sweden has made a supplemental contribution of UA 20 million to ADF-X to reduce the gap.
