1. The African Development Bank (hereafter designated as “the Bank” or “the AfDB”) is desirous to enter into agreement with a Contractor(s) who has skills in outfitting works to outfit its office premises at Joina City, Harare Zimbabwe.
2. The Bank invites sealed bids from prospective Bidders who have registered with the Bank to participate in bidding for these works of partitioning. 3. All works to be provided under this solicitation shall be provided by vendors from eligible member countries of the African Development Bank. A list of eligible member countries is available and accessible at the Bank’s website www.afdb.org/en/about-us/members
4. **The minimum Qualification criteria;**
 - (a) Bidders must originate from one of the Bank’s member countries, be established under the laws of a member country, whose the majority of the capital is owned by nationals of member countries, and which are settled in one of the member countries.
 - (b) The annual average turnover for the last three years, (2008, 2009, and 2010) for each lot shall be as follows:
 - i) Lot 1: Builders works: *Three Hundred Thousand United States Dollar (US\$ 300,000);*
 - ii) Lot 2: Electrical: *Ninety Thousand United States Dollar (US\$ 90,000);*

- iii) Lot 3: IT & Telecommunications: *Seventy Five Thousand United States Dollar (US\$ 75,000)*;
 - iv) Lot 4: Access control: *Hundred Thousand United States Dollar (US\$ 100,000)*.
 - v) The average turnover for bidding for the entire project is the cumulative of all lots.
- (c) Experience of prime contractor in the construction industry of at least three works of a similar nature and complexity to the works required under this tender, over the last 3 years.
- (d) A Project Manager with five years' experience in works of an equivalent nature and volume.
