

## REQUEST FOR EXPRESSIONS OF INTEREST

### CONSULTANCY FOR CARRYING A WIND RESOURCE ASSESSMENT FOR THE KONIKABLO WIND PROJECT IN GHANA

1. Berkeley Energy (<http://www.berkeley-energy.com>) is a renewable energy investment manager that invests in Asian and African emerging markets. Berkeley Energy currently manages the Africa Renewable Energy Fund (“AREF”). AREF is a USD \$200m fund (final close in Q3 2015) corner stoned by the African Development Bank (“AfDB”) to invest into development stage renewable energy projects. A General Procurement Notice for AREF was published on 30th September 2014.
2. AREF is considering an investment into a potential 50 MW Wind project in Ghana.
3. This request for an Expression of Interest (“EOI”) is in relation to **seeking the services of a consulting firm to undertake a Wind Resource Assessment for the purposes of checking, validation and verification of the wind potential in the project area.** In order to undertake this service, the consultant will also have to install of the following items:
  - Supply of 100 meters lattice tower
  - Supply of sensors and all the required wind measurement equipment
  - Transport to the supplied equipment to site (approximately 60 km from the Port of Tema)
  - Installation of the met mast
4. Berkeley Energy now invites eligible consultancy firms to indicate their interest in providing these services. Interested firms must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.).

AREF invites suitably experienced firms to indicate their interest in providing the above services and being invited to tender, and to be included on the electronic issue of the Tender Documents when they are made available. The tender is intended to be run in accordance with the African Development Bank’s “Rules and Procedures for the use of Consultants” (May 2008 edition, revised in July 2012), which is available on the Bank’s website at <http://www.afdb.org>.
6. Please note that interest expressed by a Company does not imply any obligation on the part of AREF to include it in the shortlist or to continue with the tender as outlined within this EOI. A non-response indicates that your Expression of Interest has not been successful.
