1. This Specific Procurement Notice follows the General Procurement Notice for this project which appeared in the UN Development Business Issue No. 693 dated 31 December 2006.
2. The Government of Mozambique has received a loan from the African Development Fund (hereafter called the Bank) in the amount of UA 12.460.000,00 towards the cost of Family Farming Income Enhancement Project, and intends to apply part of the funds of the loan to cover eligible payments under the contract for the Extension of a *Breeder Farm in Namaacha*. Bidding is open to all bidders from eligible member countries as defined in the Bank's Rules of Procedure for the Procurement of Goods and Works.
