1. This Specific Procurement Notice follows the General Procurement Notice which was published on the United Nation Development Business(UNDB) Website on 1st June 2009
2. The Government of Liberia has received a grant equivalent to UA 12,000,000 from the African Development Fund (ADF) to finance the Agriculture Sector Rehabilitation Project. The Government intends to apply part of the proceeds of the grant to cover eligible payments under the contract for the supply of 4WD Station Wagon and Pickups Vehicles. Bidding is open to all bidders as defined in the AfDB's Rules and Procedure for the Procurement of Goods and Works.

5. The Instructions to Bidders and General Conditions of Contract contained in the bidding documents comply with the Bank's rules of procedure for the Procurement of Goods.
6. Bids shall be valid for a bid period of 120 (One hundred and Twenty) days after Bid Opening and must be accompanied by the **bid security of USD10, 000.00** and be delivered to the

Project Coordination Unit (PCU) on or before 12 noon local time on **Monday 23rd August, 2010**
