1. This Specific Procurement Notice follows the General Procurement Notice (GPN) for this project which appeared in the UN Development Business No. 647 of 31st January, 2005.
2. The Government of the United Republic of Tanzania has received a loan from the African Development Fund (ADF) and intends to apply part of the proceeds of the loan to cover eligible payments under the contracts for the Construction / Upgrading Irrigation schemes for Mkuti, Luhala and Kisangwa. The bid is open to all eligible bidders as defined in the ADF's Rules of Procedure for the Procurement of Goods and Works.
3. The Ministry of Agriculture Food Security and Cooperatives Tender Board now invites sealed bids from prospective bidders for the Construction / Upgrading Irrigation schemes for Mkuti, Luhala and Kisangwa. The Scope of works is packaged in three (3) Lots and each Lot forms an independent Contract. **Bidders may bid for any or all of the following lots:**
