The Government of the Republic of Uganda, acting through the Permanent Secretary of Ministry of Education and Sports (hereinafter referred to as the “Purchaser”) has received a Loan from the African Development Fund in various currencies towards the cost of “**Uganda Post-Primary Education & Training Expansion and Improvement Project (ADB Education IV)**” and intends to apply part of the proceeds of this Loan to cover eligible payments under the contract for the Supply of Agricultural Tractors to 25 Institutions.
