- 3) Evaluation will be conducted according to criteria published in the Request for Proposal as outlined below:
- 4) **Administrative evaluation criteria**
  - Interested companies must originate from one of the Bank’s member countries.
  - Provide audited Financial Statement for the past three years ( 2007 and 2008, 2009 or latest )
  - Manufacturer’s authorization.
  - The bidder should have a minimum of five years experience, and shall have successfully implemented as a principal contractor, a minimum three projects of a similar nature
  - Products should be from ADB Member countries
- 5) **Technical evaluation criteria**
  - General information and response to questionnaire on software functionalities.
  - Response to case study
  - Information on project implementation phase and technical assistance.
  - Qualification and quality of proposed key personnel
  - Live demonstration of the system
- 6) Bidders will be awarded the contract according to the evaluation criteria indicated above and further specified in the RFP.
