The Government of the United Republic of Tanzania has received a loan and grant from the African Development Fund/Bank towards the cost for implementation of District Agriculture Sector Investment Project and intends to apply part of the proceeds of this grant and loan for eligible payments under the contract for the provision of consultancy services for designing and supervision of rural feeder roads to 28 districts as follows:

RURAL FEEDER ROADS

LOT DESCRIPTION OF CONSULTANCY

1	Seven (7)Rural Districts for Shinyanga Region – Approximately 75 Kilometres
2	Seven (7)Rural Districts for Kagera Region - Approximately 75 Kilometres
3	Six (6)Rural Districts for Mwanza Region– Approximately 65 Kilometres
4	Five(5)Rural Districts for Mara Region– Approximately 55 Kilometres
5	Three (3)Rural Districts for Kigoma Region– Approximately 35 Kilometres

3. The Ministry of Agriculture Food Security and Cooperatives now invites consulting firms to indicate their interest in providing the services. Interested firms must provide a statement of capability and experience indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills etc.). The consultants may express the interest in one or more lots, and evaluation shall be undertaken independently for each lot. This advertisement is open to consultants from eligible member countries.
