**REQUEST FOR EXPRESSION OF INTEREST FOR CONSULTANCY SERVICES FROM
SPECIALIZED NON GOVERNMENTAL ORGANIZATIONS (NGOs)**

This Request for Expression of Interest (EoI) follows the General Procurement Notice for this Project that appeared in the UN Development Business online on 27th May, 2009.

The Government of the United Republic of Tanzania has received a Loan and Grant from the African Development Fund (ADF) and intends to apply part of the proceeds of the Loan to cover eligible payments under the contract for consultancy services for specialised Non Government Organisation to supervise construction of school water supply and sanitation (WASH) facilities in Zanzibar and carry out WASH promotion in schools plus sanitation and hygiene awareness promotion in rural areas.

The scope of services include: (i) supervision of construction contracts for school water supply and sanitation facilities in Unguja and Pemba; plus building capacities on operation and maintenance of the facilities; (ii) provision of water, sanitation and hygiene awareness in 47 schools in 5 districts of Unguja and 46 schools in 4 districts of Pemba; (iii) sanitation and hygiene promotion/campaign in rural areas in Unguja and Pemba. The assignment is planned to commence in February 2012.

The Zanzibar Water Authority now invites Non Governmental Organizations (NGOs) to indicate their interest in providing the services. Interested NGOs must provide a statement of capabilities and experience indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.) in the last 10 years. The Expression of Interest (EoI) should include but not be limited to (i) detailed Curriculum Vitae of staff including certified copies of professional and academic qualifications (ii) full time contact mail address and/ or mobile phone numbers (iii) contact details of the Clients in the last 5 years.

A shortlist of six (6) NGOs will be compiled in accordance with procedures set out in the African Development Bank's rules and procedures for the use of Consultants (May 2008). Borrowers are under no obligation to select any NGO who expressed interest.

Interested NGOs may obtain further information at the address below during the Office hours from 8.30 a.m to 3.30 pm time from Monday to Friday except in public holidays.
