The Government of the United Republic of Tanzania (URT) has received a loan to the amount of UA 5.2 Million from the African Development Fund to finance the Institutional Support Project for Good Governance II (ISPGG II) and intends to apply part of the proceeds to payments for goods, and/or services to be procured under this project.
2. The principal objective of the project is to support the Improvement of Transparency and Accountability in the Public Financial Management System through the Enhancement of the Capacity, Accountability and Integrity of Managing Public Resources in Tanzania Mainland and Zanzibar.
3. The main components of the project are:
 - (i) Improving Budget Credibility and Transparency: That covers capacity building in areas of public procurement and audit.
 - (ii) Enhancing Economic Policy Management: That includes capacity building in key elements of the Public Financial Management Reform Program (PFMRP) and improving the business environment in general.
4. Key procurement activities in the project's:

Goods: The project shall procure equipment to support its activities. This includes motor vehicles office equipment and furniture.

Services: Key consulting services of the project shall include: Diagnostic Survey on Corruption in Roads Infrastructure; Development of Procurement Manual Capacity Building in Assets Tracking Recovery; Review of Zanzibar Procurement and Disposal Act of 2005; Audit Services; Technical Assistance on Monitoring and Evaluation of PFMRP and; Technical Assistance for facilitating Legal, Technical and Other Reforms to Accommodate E-procurement in Tanzania.

Training and Workshops: The training and workshop services will include: participatory budgeting; auditing; parliamentary capacity building and; procurement. These will be carried out by individual consultants and training institutions.
