UPGRADING OF NYAKAHITA - KAZO ROAD
INVITATION FOR PRE-QUALIFICATION
CONTRACT NO. ADF/HW/C014A

1. This invitation for pre-qualification follows the General Procurement Notice for this project that appeared in the United Nations Development Business dated 02 July 2009.
2. The Government of the Republic of Uganda has received a loan from the African Development Fund (ADF) hereinafter referred to as the Bank, towards the cost of the Road Sector Support Project 3 (RSSP3), and intends to apply part of the proceeds of the loan to eligible payments under the contract for which this Invitation for Pre-qualification is issued.
3. The Uganda National Roads Authority (UNRA), herein referred to as the “Employer”, intends to pre-qualify firms for the following contract under this project:
Upgrading of Nyakahita – Kazo Road: Contract No. ADF/HW/C014A
4. The Nyakahita – Kazo road (68Km) is located in Kiruhura district in the South Western part of Uganda. The project road is currently a gravel road of Class B standard and is to be upgraded to class II bitumen standard having a double bitumen surface treated carriageway of 6.0 m width and surfaced shoulders on either side. The road starts at Nyakahita, which is located approximately 201Km from Kampala on the Kampala – Mbarara highway and traverses a rolling to hilly terrain.
5. Pre-qualification is open to firms and voluntarily formed joint ventures from eligible source countries, in accordance with the *Bank Rules and Procedures for Procurement of Goods and Works*.
6. Interested eligible Applicants may obtain further information from and inspect the bidding documents at the address below, from 09:00 hours to 17:00 hours on working days. Prequalification documents may be obtained after 15 October 2009 on submission of written application to the Employer.

7. The request must clearly state “**Request for Pre-qualification Documents for Upgrading of Nyakahita – Kazo Road – Contract No. ADF/HW/C014A**”.
8. A complete set of Pre-qualification documents in English may be purchased by interested Applicants on the submission of a written application to the above address and upon payment of a non-refundable fee of US\$ 50,000 (Fifty thousand Uganda shillings) or an equivalent amount in a freely convertible currency. The method of payment will be cash or bank certified cheque or banker’s draft in favour of Uganda National Roads Authority. In case the applicant wishes to have the prequalification documents sent by courier or any other means, the charges should be prepaid to the nominated courier. The Uganda National Roads Authority (UNRA) will promptly dispatch the documents but under no circumstances will UNRA be held responsible for late delivery or loss of the documents so dispatched.
9. A minimum requirement for qualification is to have successfully carried out the following:
 - (a) average annual turnover as prime contractor (defined as billing for works in progress and completed) over the last 5 years of **US\$ 46,000,000 (United States dollars Forty Six million)** or equivalent; and
 - (b) Successful experience as prime contractor in the execution of at least two projects of a nature and complexity comparable to the proposed contract within the last five (5) years, each with a value of at least **US\$ 55,000,000 (United States Dollars Fifty five million)**. A minimum construction experience for pre-qualification is required in the following key activities:
 - Earthworks of 850,000 m³/year
 - Rock fill of 10,000 m³/year
 - Rock Excavation of 10,000 m³/year
 - Natural gravel sub-base of 95,000 m³/year
 - Graded crushed stone base of 70,000 m³/year
 - Double Bitumen Surface Treatment of 340,000 m²/year
 - Concrete Works of 8,000 m³/year

11. Late applications shall be rejected.

12. Applicants will be advised, within a reasonable time, on the results of their applications. Only firms and joint ventures pre-qualified under this procedure will be invited to bid.
