1. Introduction / Background

2. Objectives of the Assignment

The Individual Consultant will be responsible for providing broad-based support to the department and its constituent divisions for ongoing/new sustainable energy programmes and projects.

3. Main activities and deliverables

The Assignment will include, but not be limited to:

- 1) preparation of investment operations (and where relevant technical assistance interventions) related to sustainable energy — renewable energy, energy efficiency and clean cooking — with an emphasis on opportunities in North Africa (in particular Morocco and Tunisia) and West Africa (in particular Senegal)
- 2) development of country-specific equity/debt funds for sustainable energy in the context of the Africa Renewable and Energy Efficiency Platform
- 3) support for the Desert-to-Power Initiative
- 4) undertake any other tasks that the Department's managers or director may assign
