JOMO KENYATTA INTERNATIONAL AIRPORT AIRFIELD EXPANSION PROJECT: SECOND RUNWAY DEVELOPMENT

The Government of Kenya has received a loan from the African Development Bank to finance the Jomo Kenyatta International Airport Airfield Expansion Project and intends to apply part of the proceeds for this loan for Construction of **Second Runway at Jomo Kenyatta International Airport**.

The principal objectives of the project are to:

- i) Improve reliability of air service for JKIA by having a second runway to cover the uncertainties currently associated with the existing runway.
- ii) Improve capacity to accommodate fully loaded Class F aircraft such as Airbus 380.
- iii) Enhance payload capacity for direct non-stop flights to North America.
- iv) Improve airport capacity to achieve the goal set out in Vision 2030 to accommodate 45 million passengers.
- v) Generate employment at the airport as well as have a multiplier effect of generating employment outside the airport.
- vi) Contribute towards overall development of the national economy as well as regional integration.

The project includes the following components:

- 1 Civil works contract to include:
 - Construction of a new runway and taxiways to include marking and drainage works
 - Provision and installation of Airfield Ground Lighting (AGL)
 - Provision and installation of Navigation Aids Equipment (Nav aids)
 - Provision and Installation of Meteorological systems.
 - Construction of Air Rescue and Fire Fighting (ARFF) station
- 2 Consultancy Services shall include:
 - Runway Construction Supervision
 - Monitoring & Evaluation and Technical Audit
 - Formulation of JKIA Master Plan & National Airport Development Strategy
- 3 Goods supply for:
 - Air Traffic Control (ATC) Equipment
 - 5 No. Air Rescue and Fire Fighting Trucks
 - 5 No. Ambulances
- 4 Technical Assistance & Institutional Support
 - Airport Pavement Maintenance Study
 - Training of KAA & KCAA Staff

The procurement of civil works will be carried out under Open Competitive Bidding with post qualification of contractors in accordance with the AfDB's Procurement Policy for Bank Group Funded Operations dated October 2015, with notifications at international level.

The procurement of construction supervision consultancy services and Monitoring and Evaluation have commenced; procurement of civil works and supply of goods are expected to start in February 2018.
