Rwanda Sustainable Water Supply and Sanitation Program: Additional financing GENERAL PROCUREMENT NOTICE (GPN)

1. The Government of the Republic of Rwanda has received a loan from the African Development Bank (“the Bank”) and a grant from the Rural Water Supply and Sanitation Initiative (RWSSI) Trust Fund administrated by the Bank to finance the **“Rwanda Sustainable Water Supply and Sanitation Program - Additional financing”**. The project is jointly financed by the Bank and the Government of Rwanda. The Water and Sanitation Corporation, WASAC Ltd is the Implementing Agency. WASAC Ltd therefore intends to apply the proceeds of these funds for payments of all works and services to be procured under this program.

2. The overall objective of this program is to improve the quality of life and of socio-economic development of the people and country by ensuring equitable provision of adequate, reliable and sustainable water and sanitation services for all.
