

# GENERAL PROCUREMENT NOTICE

Chinsali – Nakonde Road Rehabilitation Project (North – South Corridor)

1. The Government of the Republic of Zambia has applied for a loan from the *African Development Bank* to finance the Chinsali – Nakonde Road Rehabilitation Project (North – South Corridor).

2. The principal objective of this project is to :

*Improve road transport infrastructure and services in the COMESA/EAC/SADC region through development of the priority road corridor and thereby reduce transport costs between northern Zambia and southern Tanzania.*

3. The project includes the following components :

**A. Component 1: Civil Works**

- i. Reconstruction of 210 km of road between Chinsali and Nakonde which shall be procured under two separate Lots.
- ii. Rehabilitation of 50 km of Feeder Roads in the project area.

**B. Component 2: Consultancy Services**

- i. Design Review and Supervision of Construction Works.
- ii. Sensitisation of Project Area Inhabitants on Communicable Diseases (HIV/AIDS, STIs, malaria); gender mainstreaming and Environmental Protection
- iii. Project Financial Audits.
- iv. Technical Audits.
- v. Project Monitoring and Evaluation of Impacts.
- vi. Road Safety
- vii. Sector Studies
  - Feasibility Study and Detailed Design for the Feira Crossing in Luangwa on the Zambezi River.
  - Pre-Feasibility Study for the Nakonde/ Tunduma Border/ Update of the Border Development Master Plan.

**C. Component 3: Trade Facilitation**

- i. Corridor Improvement Support Consultancy.

**D. Component 4: Resettlement and Compensation**

- i. Compensation of Project Affected Persons.

**E. Component 5: Institutional Support and Capacity Building**

- i. Technical Assistance/ Advisory.
- ii. Training and Capacity Building for women and youth in construction.
- iii. Technical Assistance/ Maintenance Management.
- iv. Technical Assistance/ Sector Investment Programme Development.
- v. Project Management and Coordination.

4. Procurement of goods and/or works will be in accordance with the Bank's Rules of Procedure for the Procurement of Goods and Works. Acquisition of the services of Consultants will follow the Bank's Rules and Procedures for the Use of Consultants. Bidding documents are expected to be available in August 2015.
