This Invitation for Bids follows the General Procurement Notice (GPN) for this program that appeared in UNDB online n° AfDB23-792/11 of 18th January 2011 and on the African Development Bank Group's Internet Website.

The Government of the Republic of Rwanda, through the East Africa Community, has received a grant from African Development Fund towards the cost of Lake Victoria Water Supply and Sanitation Program Phase II (LVWATSAN II). It is intended that part of the proceeds of this grant will be applied to eligible payments under the contract for construction works of public toilets, rehabilitation and construction of storm water drainage systems in Nyagatare, Nyanza and Kayonza towns.

EWSA (the Implementing Agency) now invites sealed bids from eligible bidders for the construction and completion of public toilets, rehabilitation and construction of storm water drainage systems in Nyagatare, Nyanza and Kayonza towns.

Interested eligible bidders may obtain further information from and inspect the Tender Document at the Procurement Office of LVWATSAN-II, EWSA Office located at Remera on Kigali International Airport Road.

The Tender Document may be obtained on any working day at the above mentioned address upon presentation of proof of payment of a non-refundable fee of fifty thousand Rwandan Francs (RWF 50,000). This fee shall be paid at BNR on the Account n° 120.00.46 of Rwanda Revenue Authority.

The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the African Development Bank Standard Bidding Document: Procurement of Works.

Compulsory sites visit are scheduled from **25th to 27th June 2013** and will be conducted by representatives of EWSA. The venue for departure is fixed at 8:00 am local time at EWSA Office located at Remera on Kigali International Airport Road.

Bids must be delivered to the above office on or before 10:30 a.m. local time on **30th July 2013** and must be accompanied by a security of **RWF 40,000,000**. Bids will be opened in the presence of bidders' representatives who choose to attend on the same day at 11:00 a.m. local time in the conference room of EWSA at the above mentioned office.
