The Federal Democratic Republic of Ethiopia has received Financing from the African Development Bank in various currencies towards the cost of Drought Resilience and Sustainable Livelihoods Program (DRSLP-II). It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for the **Procurement of Tsetse Suppression Drugs, Insecticides and Equipments.**
