1. This Invitation for Bids (IFB) follows the General Procurement Notice (GPN) for this Project that appeared in United Nations Development Business online (www.devbusiness.com) No. AfDB1099-10/16 and on the African Development Bank's website (www.afdb.org) on 20 October 2016.
2. The Government of the Republic of Uganda received funds from the African Development Fund towards the cost of Multinational Lakes Edward and Albert Integrated Fisheries and Water Resources Management (LEAF II) Project. It is intended that part of the proceeds will be used for payments under the contract for the *Supply of a Fisheries Research Vessel for Lake Albert in Uganda (Proc. Ref. No. MWE/SPLS/18-19/000230)*.
3. The Ministry of Water and Environment now invites sealed Bids from Bidders for **Supply of a Fisheries Research Vessel** designed according to International Maritime Organization (IMO) Standards.
4. Interested bidders may obtain further information from the address below during office hours from 08:30 to 17:00 hours Ugandan Time.
5. A complete set of Bidding Documents in English may be purchased by interested bidders upon payment of a non-refundable fee of **UGX 100,000 (One Hundred Thousand Uganda Shillings)**. The method of payment will be through the Bank using Bank advice forms available and can be picked from the Ministry's cash office.
6. The provisions in the Instructions to Bidders and in the General Conditions are those of the Bank's Standard Bidding Document for Procurement of Goods.
7. Bids must be delivered to the address below not later than **Thursday 25th April, 2019 at 1100 HRS** local time. All bids must be accompanied by a bid security of **USD 18,000 (Eighteen Thousand United States Dollars) or its equivalent in a freely convertible currency**.
8. Bids shall remain valid for **120 days** after the deadline for bid submission prescribed above.
