The Government of the Republic of Rwanda (GoR) received funds from the African Development Bank under the Multinational (Burundi/Rwanda) Road Project (MUGINA - MABANDA - NYANZA LAC AND RUBAVU-GISIZA) and trade facilitation on North - south corridor, phase III and intends to apply part of the agreed amount for upgrading works of additional roads sections under Rubavu - Gisiza road project. All bidders, meeting the criteria of origin as defined in the African Development Bank Group Rules of Procedure for the procurement of goods and works, are allowed to compete. This tender is a unique package split into five (5) sub-lots (indivisible lot) as follows:
 - **Sub-Lot1: Murunda Hospital tarmac access road (4.2Km);**
 - **Sub-Lot2: Bralirwa - Burushya tarmac road (4.1Km);**
 - **Sub-Lot3: Bralirwa - Rubavu tarmac road (6.2Km);**
 - **Sub-Lot4: Symbion Methane Gas Plant access road (4.5Km) And**
 - **Sub-Lot5: Installation of street lights along Gisiza - Rubavu Road and Portable Electronic Wheel-Load Weighing Scales**
2. Rwanda Transport Development Agency (RTDA) hereby invites eligible and qualified bidders to submit bids for the above additional works under RUBAVU - GISIZA Road.

A complete set of Bidding Documents may be obtained by interested bidders at the office of RTDA at the above address from **18/04/2018** during working days/hours upon payment of a non-refundable fee of One hundred Thousand Rwandan Francs only (100,000 FRW) or in a convertible currency deposited on account No. 120.00.46 of Rwanda Revenue Authority opened at the National Bank of Rwanda (BNR).

5. The provisions of the Instructions to Bidders and those of the General Conditions of Contract are the provisions of the African Development Bank Standard Bidding Document: Procurement for works.
6. Bids must be delivered to the above mentioned office not later than **07/06/2018 at 10:00 a.m., local time (8:00 GMT)** and must be accompanied by a Bid Security in the form of a reputable Bank Guarantee only in the amount of Five Hundred Million Rwandan Francs (**500,000,000 FRW**) or its equivalent in a freely convertible currency.
7. Bids will be opened in the presence of bidders' representatives who choose to attend, on the same day, **at 10:30 A.M local time (8:30 GMT)**.
8. The bids will remain valid for a period of one hundred (120) days from the deadline for submission of the bids.
9. As an indication, the execution period is estimated to twelve (12) months. A recommended site visit (non-mandatory), will be organized by Rwanda Transport Development Agency and the departure is at Rubavu District at eleven (11) o'clock, local time (9:00 GMT) on **03/05/2018**.
