1. This Invitation for Bids follows the General Procurement Notice (GPN) for this project that appeared in the *UN Development Business* online of 24<sup>th</sup> July 2013 and on the African Development Bank Group's Internet Website.

The Government of Uganda has received a Loan from the African Development Fund (ADF) in various currencies towards the cost of Uganda: Support to Higher Education, Science and Technology (HEST) Education V Project. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for the **Supply, Installation, and Commissioning of Learning Management Systems (LMS), Integrated Library Systems (ILS) and Professional Certification Training for Technical Staff for Beneficiary Institutions - LOT 3C**.
3. The Ministry of Education and Sports (hereinafter referred to as "the Executing Agency") now invites sealed Bids from eligible Bidders for the **Supply, Installation, and Commissioning of Learning Management Systems (LMS), Integrated Library Systems (ILS) and Professional Certification Training for Technical Staff for Beneficiary Institutions - LOT 3C**, under International Competitive Bidding (ICB) and will be conducted in accordance with the AfDB's *Rules and Procedures for Procurement of Goods and Works (May 2008 Edition Revised July 2012)*

A Revised set of Bidding Documents with the clarifications can be obtained by the prospective bidders upon the submission of a written application to the said Executing Agency, and on payment of a non-refundable fee of UGX100,000/= (Uganda Shillings One Hundred Thousand Only). Bidders who have already purchased the bidding documents will be issued a complete set of clarifications without making new payments.
6. The provisions in the Instructions to Bidders and in the General Conditions are those of the Bank's Standard Bidding Document for Procurement of Goods.

The deadline for bid submission is EXTENDED from **3<sup>rd</sup> July 2018 to a new date of 25 July, 2018** at 11.00 am local time (=GMT+3 11:00 a.m. and bids must be accompanied by a bid security in form of an Unconditional Bank Guarantee in the amount of **USD 21,000** (United States Dollars Twenty One thousand only)
