Invitation for Bids

Urgent Water Supply and Sanitation Rehabilitation Project – Phase II

Supply of Equipment for PRV and Water Meter Chambers in the distribution network of Harare and Related Services ICB Reference: UWSSRP/018B

1. This invitation for Bids follows the General Procurement Notice for this project that appeared in the *United Nations Development Business online (UNDB online)* No. AfDB496-07/14 of 24th July 2014 and on the African Development Bank's Internet Website (www.afdb.org) on 30th July 2014.
2. The Ministry of Finance and Economic Development, Government of the Republic of Zimbabwe has received a grant from the Zimbabwe Multi-Donor Trust Fund (Zim-Fund) administered by the African Development Bank (the Bank) to finance the Urgent Water Supply and Sanitation Rehabilitation Project Phase II (UWSSRP). It is intended that part of the proceeds will be applied to eligible payments under:

The Ministry of Finance and Economic Development has appointed Crown Agents Limited (Crown Agents) to act as its Procurement Agent. The Goods in each Lot will be delivered to Harare and subsequently the goods in Lot 1 and Lot 2 will be installed at various locations in and around Harare.

3. Bidding shall be by International Competitive Bidding (ICB), using post-qualification in accordance with the Bank's "Rules and Procedures for Procurement of Goods and Works" (May 2008 Edition, revised July 2012). Bidding is open to all bidders from eligible firms and voluntarily formed joint ventures from eligible source countries, as defined in the aforementioned Bank Rules and Procedures and the Operations Manual of the Zim-Fund.
4. A complete set of the bidding documents, in English only, may be obtained by interested bidders on the submission of a written application (with the name and full address of the bidder), by email to zimfundpa@crownagents.co.uk. The bidding documents will only be available electronically. No fee is due.
5. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the African Development Bank Standard Bidding Document: Procurement of Goods, dated September 2010, revised July 2012 and the Operations Manual of the Zim-Fund.
6. A non-compulsory site visit and pre-bid meeting will be held on 14 November 2017. Prior registration to attend is essential. Details are in the bidding documents.
7. Bids must be delivered to the address at 9 below by **13:00 hours (GMT) on 14 December 2017** and must be accompanied by a **bid security of United States Dollars Twelve thousand (USD12,000.00) for Lot 1 and/or Ten Thousand United States Dollars (USD10,000.00) for Lot 2 and/or United States Dollars Four Thousand (USD4,000.00) for Lot 3**. Bids sent electronically will **not** be accepted.
8. Bids will be opened in the presence of bidders' representatives who choose to attend at **14:00 hours (GMT) on 14 December 2017** at the address at 9 below.
