**BIDDING DOCUMENT FOR SUPPLY AND INSTALLATION OF A BULK SUPPLY POINT &
INTERCONNECTING CIRCUITS AT JUABESO IN THE WESTERN REGION OF GHANA

1. This invitation for bids follows the general procurement notice for this project that appeared in UNDB online, issue no. AfDB408-06/14 of 13th June, 2014 and on the African Development Bank Group's Internet Website.
2. The Government of Ghana has received a Loan and Grant facilities from the African Development Fund toward the cost of implementing the Electricity Distribution System Reinforcement and Extension Project, and it intends to apply part of the proceeds of this loan to payments under the contract for Supply and Installation of 33kV Bulk Supply Point & Interconnecting Circuits at Juabeso in the Western Region of Ghana, Bid No: ECG/GEDAP III/AfDB/ICB/WS/2015/02
3. The Electricity Company of Ghana now invites sealed bids from eligible bidders for the bid for Supply and Installation of 33kV Bulk Supply Point & Interconnecting Circuits at Juabeso in the Western Region of Ghana. The works comprise;
 - i. The supply, installation, testing and commissioning of a 33kV Bulk Supply Point i.e. Juabeso Bulk Supply Point and Connecting Circuits at Juabeso in the Western Region of Ghana.
 - ii. The supply, installation, testing and commissioning of 33kV identified circuits from the planned Juabeso Bulk Supply Point to connect to the existing network (***A total of six (6) circuits approximately 20 cct-km are to be constructed***).
 - iii. The supply, installation, testing and commissioning of SCADA facilities for the Bulk Supply Point.

To be eligible for Award of Contract, Bidders shall provide satisfactory evidence to the Employer of their eligibility and of their capability and adequacy of resources to carry out the contract effectively. To this end, all Bids submitted shall include the following:

- a. Copies of original documents defining the constitution of legal status, place of registration and principal place of business of the company or firm.
- b. Details of the experience and past performance of the Bidder on works of a similar nature within the past five years, and details of current work in hand and other contractual commitments.
- c. Major items of constructional plant proposed for use in carrying out the contract.
- d. The qualifications and experience of key personnel proposed for administration and execution of the Contract, both on and off site.

- e. Reports on the financial standing of the Bidder such as profit and loss statements, balance sheets and auditor's reports for the past five (5) years, and an authority from the Bidder to seek references from the Bidder's bankers and information regarding any current litigation in which the Bidder is involved.

A complete set of bidding documents in English may be purchased by interested bidders on the submission of a written application to the address above and upon payment of a nonrefundable fee of \$ 250 (US Dollars). The method of payment will be by cash or Bank Draft. The documents may be collected by hand at the above office or will be sent by courier at an additional cost of \$ 20 for delivery in Ghana and \$100 for overseas deliveries.
6. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the African Development Bank Standard Bidding Document: Procurement of Goods or Procurement of Works
7. Bids must be delivered to the address **(A)** shown below at or before **10.00 hours on 10th May, 2017**. Bids must be accompanied by a bid security or a bid bond in an amount of **Ninety Thousand United States Dollars (US\$ 90,000)**. Late bids will be rejected. Bid Securities that do not accompany the Bid, but that are tendered after the time of close of Bids, will be rejected and the Bids will be declared non-responsive, irrespective of any evidence or notification prior to or after Bid Opening that the Security has been issued or is in the process of being issued by the Bank at the time of Bid opening. For that matter photocopies, FAX copies and copies other than the original of Bid Securities accompanying Bids will not be considered valid, and will be rejected.
8. Bids will be opened in the presence of the bidders' representatives, who choose to attend at the address **(B)** below immediately after **10.00 hours on 10th May, 2017**.
