The Lake Victoria South Water Services Board (LVSWSB) through the **East African Community (EAC)** has received a Grant from the **African Development Fund** in various currencies towards the **Lake Victoria Water Supply and Sanitation Program, Phase II (LVWATSAN II), for Kericho, Keroka and Isebania** and intends to apply part of the proceeds of the Grant to cover eligible payments under the contracts for **Supply and Delivery of 7No. Tractors**.
3. The Lake Victoria South Water Services Board now invites sealed bids from prospective bidders for **Supply and Delivery of 7No. Tractors, (Tender No. LVSWSB/T/13/2015-2016(R))**.
