The Government of the Republic of Rwanda (GoR) has applied for financing from the African Development Bank Group (in *co-financing with EU and with Japan International Cooperation Agency (JICA) respectively*) and intends to apply part of the agreed amount for the loan to payments under the contract for the rehabilitation and widening works of Kagitumba-Kayonza-Rusumo Road. This tender is split into three lots as follows:

- **Lot 1: Rehabilitation and Widening of Kagitumba-Bugaragara-Gabiro road (60km) in two sections: Kagitumba-Bugaragara road (25km) and Bugaragara-Gabiro road (35km), and ancillary works (rehabilitation of six (6) milk collection centers and construction of 10 water boreholes).**
- **Lot 2: Rehabilitation and widening works of Gabiro-Kayonza road (56km) and ancillary works (rehabilitation of four (4) milk collection centers).**
- **Lot 3: Rehabilitation and Widening works of Kayonza-Rusumo road (92km).**

**For a bidder to be awarded more than one Lot, it shall provide separate equipments' and personnel for each Lot.**

2. The "Rwanda Transport Development Agency (RTDA) / MININFRA" now invites sealed bids from eligible bidders for the procurement of above rehabilitation and widening works, following International Competitive Bidding (ICB) procurement method for the above mentioned works.

A complete set of Bidding Documents may be obtained by interested bidders from 7/03/2016 during working days/hours upon payment of a non-refundable fee of One hundred Thousand Rwandan Francs only (100,000 Rwf) or in a convertible currency deposited on account No. 120.00.46 of Rwanda Revenue Authority opened at the National Bank of Rwanda (BNR).
5. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the African Development Bank Standard Bidding Document: Procurement for works.
6. Bids must be delivered to the above mentioned office not later than **19/04/2016 at 10:00 A.M local time (GMT+2)** and must be accompanied by a Bid Security, in a form of a reputable Bank Guarantee only of an amount as follows:
- **Lot 1: a bid security that is equivalent to Five Hundred Thousand United States Dollars (500,000 USD)** or its equivalent amount in a freely convertible currency;
  - **Lot 2: a bid security that is equivalent to Five Hundred Thousand United States Dollars (500,000 USD)** or its equivalent amount in a freely convertible currency;
  - **Lot 3: a bid security that is equivalent to One Million United States Dollars (1,000,000 USD)** or its equivalent amount in a freely convertible currency
