1. This Invitation for Bids follows the General Procurement Notice (GPN) for this project that appeared in the *UN Development Business* online of 24th July 2013 and on the African Development Bank Group's Internet Website.

The Government of Uganda has received a Loan from the African Development Fund (ADF) in various currencies towards the cost of **Uganda: Support to Higher Education, Science and Technology (HEST) Education V Project**. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for the **Supply, Delivery and Installation of Furniture to Various Beneficiary Institution's Under the ADB V HEST Project (under Lot 4.01, 4.02, 4.03, 4.04, 4.05 and Lot 4.06)**.

The Ministry of Education and Sports (hereinafter referred to as "the Executing Agency") now invites sealed Bids from eligible Bidders for the **Supply, Delivery and Installation of Furniture to Various Beneficiary Institution's Under the ADB V HEST Project (under Lot 4.01, 4.02, 4.03, 4.04, 4.05 and Lot 4.06)** as indicated in the table below, hereinafter called "the Goods"). International Competitive Bidding will be conducted in accordance with the Bank's *Rules and Procedures for Procurement of Goods and Works (2008, revised July 2012)*.
