1. This Invitation for Bids follows the General Procurement Notice (GPN) for this project that appeared in UNDB online (AFDB711-07/17) of 18 July 2017 and on the African Development Bank Group's Internet Website.
2. The Government of the Republic of The Gambia has received Grant from the African Development Bank towards the cost of Inclusive Growth Promotion and Institutional Support Project (IGPISP). It is intended that part of the proceeds of this grant will be applied to eligible payments under the contract for the Supply and Installation of Trade Fair Equipment for the Gambia Chamber of Commerce and Investment (GCCCI).
3. The Ministry of Finance and Economics Affairs (MOFEA) now invites sealed bids from eligible bidders for the supply and installation of Trade Fair equipment as follows:
  - Mini Pagoda Tents
  - Octagon Tents
  - Mobile Toilets
4. Bidding will be conducted through International Competitive Bidding (ICB) procedures in accordance with the Procurement Policy and Methodology for Bank Group Funded Operations", dated October 2015, as amended from time to time, and is open to all eligible Bidders that meet the following minimum qualification criteria:
  - a) Proof of Business registration Certificate (Mandatory for all bidders)

- b) Proof of successful completion of minimum of two similar contracts within the last seven (7) years with values of at least \$120,000 (One hundred and twenty thousand US Dollars) each.
- c) Demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial means, other than any contractual advance payments to a value of at least \$190,000 (One hundred and ninety thousand US Dollars).
